Geocaching and Letterboxing Policy and Guidelines

Approved by Public Recreation and Parks Board – September 15, 2010

Approved by the Nature Centers Commission – October 21, 2010

Geocaching is a pastime in which “caches” or containers are hidden, to be located by others. General location and geographic coordinates of the caches are then shared via the internet. The principal geocaching internet site is: www.geocaching.com. Location coordinates are used to search for and find the caches using a Global Positioning System (GPS) device. Caches contain a variety of items; geocachers finding a cache take an item and leave a new item and make an entry in an included logbook. The cache is monitored by the cache owner.

Letterboxing is similar to geocaching in that boxes are hidden for other participants to find. Letterboxes contain a rubber stamp and a logbook; participants carry their own book that they stamp with the stamp they find in the box, and carry their own stamp which they stamp in the logbook. GPS coordinates are not used in letterboxing; instead, participants find the letterboxes based on clues. The primary website for letterboxing in North America is www.letterboxing.org.

The City of Gainesville’s Parks, Recreation and Cultural Affairs Department (PRCA) believes that geocaching and letterboxing are family-friendly forms of outdoor recreation that encourage visitation to parks, centers, and conservation areas. With proper oversight, these pastimes can be compatible with management and protection of the City’s recreation areas.

This policy establishes guidelines for approving and placing geocaches and letterboxes in City-owned parks, centers, and conservation areas to minimize adverse impacts on natural and cultural resources. This policy does not cover caches located in state parks, state forests, schools, university lands, non-park areas of municipal lands, or any other public or private lands not managed by PRCA. City-owned parks and facilities that are covered by this policy are shown in Table 1 and Figure 1.

Application Procedure:

1. Read this policy and guideline document.
2. Determine a possible location for your cache/letterbox and the type of cache/letterbox you want to place (see “Placing a Cache/Letterbox”, below).
3. Complete the permit application, as provided in this policy. Submit the application via email to parkmgr@cityofgainesville.org or by mail to Nature Operations Division, P.O. Box 490, Mail Station 24, Gainesville, FL 32602.
4. There is no fee to obtain a geocache/letterbox permit.
5. The cache/letterbox owner must provide all application information and be available to accompany PRCA staff to the proposed location, if requested.
6. A permit or denial letter will be issued to the applicant within thirty (30) days.
7. Once the proposed cache/letterbox and location are approved by PRCA staff, a permit will be issued.
8. Upon issuance of a permit, the cache/letterbox may be placed and may be posted on the appropriate website (www.geocaching.com or www.letterboxing.org).

Placing a Cache/Letterbox:

1. To prevent damage to sensitive areas, caches/letterboxes must be reachable WHILE STANDING ON A BOARDWALK, ROADWAY, TRAIL, OR WALKWAY, or other area officially

accessible to the public. The online description of the cache/letterbox MUST indicate that that the cache/letterbox can be reached from a boardwalk, roadway, trail, walkway, or publically accessible area, as applicable.

2. When choosing a location for a cache/letterbox, owners should be aware of the perception of other park visitors and non-geocachers/letterboxers. Caches/letterboxes that interfere with facility/park reservations or other recreational activities will not be approved. Cache/letterbox locations should not pose any danger to those searching for the cache/letterbox or to other visitors. PRCA retains the right to remove a cache/letterbox in the interest of protecting the park environment and/or visitor safety without notification.
3. No archaeologically, historically, or ecologically sensitive sites will be used for cache/letterbox locations.
4. No burying or digging is permitted. Cutting trees, shrubs, or plants is also prohibited.
5. Geocaches must be clearly labeled "Official Geocache" with the permit number on the inside and outside of the container. Letterboxes must be labeled "Official Letterbox" with the permit number on the outside and inside of the container. Inside the container must be a log, owner contact information, and a brief information sheet about geocaching/ letterboxing with, at minimum, the www.geocaching.com or www.letterboxing.org website address for unexpected discoverers to understand the cache/letterboxing process.
6. PRCA may issue permits for "Micro" caches (such as a 35mm film container), "Regular" caches/letterboxes (such as a plastic kitchen container), and "Virtual" caches (no cache container, the cache is the location itself). Multi-stage caches/letterboxes are not allowed due to the sensitivity of our sanctuaries.
7. Geocaches/letterboxes shall be placed at a minimum distance of 0.1 miles (528 feet) from the nearest permitted cache/letterbox. This minimum distance applies regardless of whether the closest permitted item is a letterbox or geocache. The number of cache/letterbox permits for a given park may be limited at the discretion of PRCA staff. It will not be the responsibility of PRCA to maintain any type of "wait list" for permit slots in a park.
8. No firearms, weapons, ammunition, food, alcohol, drugs, explosives, or hazardous, toxic, or "adult" items may be included in the cache/letterbox. Cache/letterbox contents must be suitable for all ages.

General Regulations:

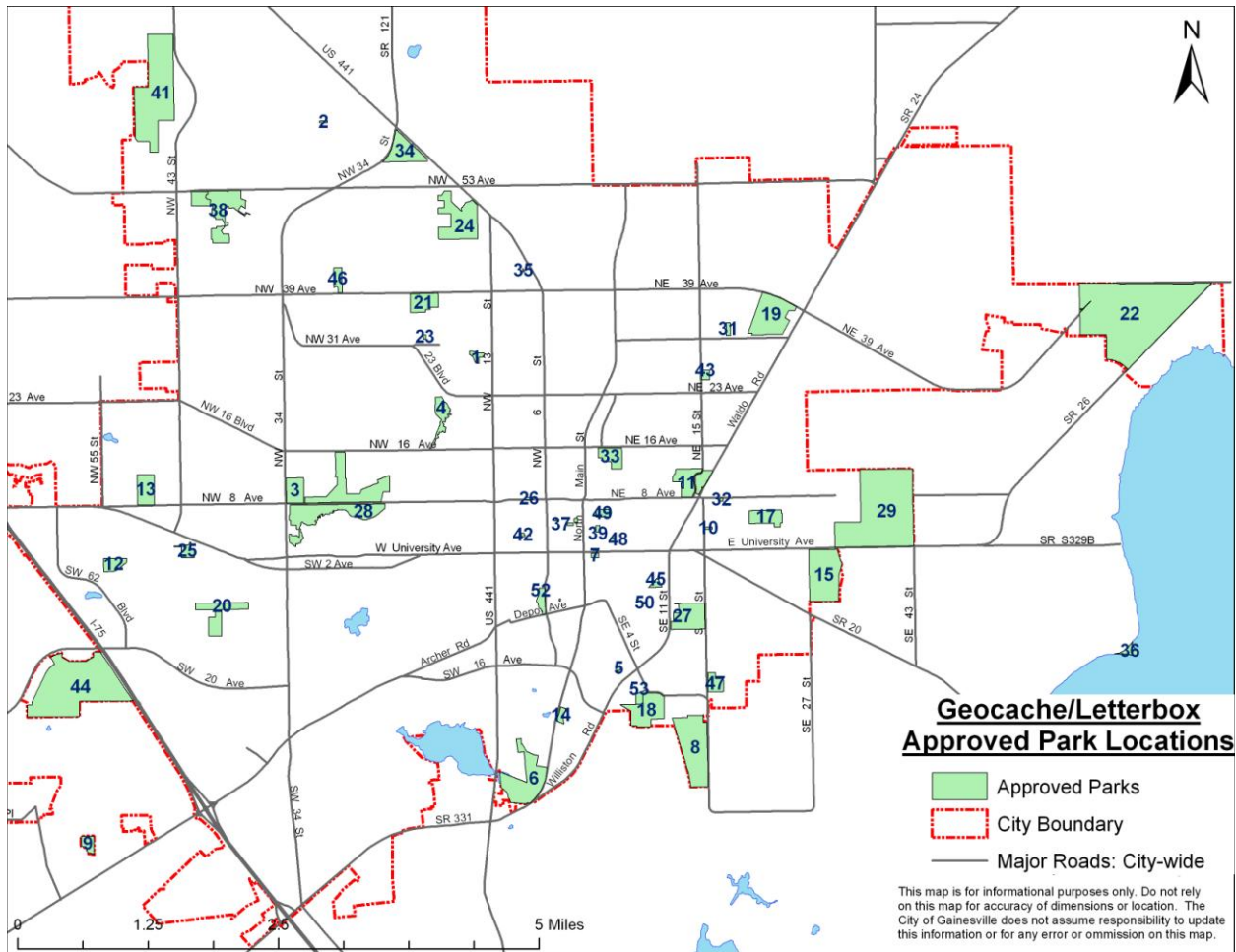
1. Maintenance and monitoring of any permitted cache/letterbox is the responsibility of the cache/letterbox owner.
2. PRCA is not responsible for lost, stolen, damaged, or inaccessible items, including caches/letterboxes damaged or destroyed by prescribed fire or other park/land management activity, or caches/letterboxes made inaccessible by any scheduled or unscheduled park closure.
3. PRCA reserves the right to remove permitted caches/letterboxes without advance notice for any reason.
4. Park hours and all other City of Gainesville Ordinances and regulations must be followed.
5. Non-permitted caches/letterboxes or caches/letterboxes moved to non-approved locations may be removed by PRCA staff at any time without notice.
6. Caches in PRCA parks shall be available to all members of the public via www.geocaching.com. Letterboxes shall be posted on www.letterboxing.org. Caches/ letterboxes with restricted or private access (such as those accessible to members only) will not be permitted.
