GRU submittals: 5 sets of the plans must be submitted directly to GRU. Planning submittal: 12 sets of plans must be submitted to the Planning Department. Plans submitted to Planning and GRU must be the exact same plans for each submittal & re-submittal.

The schedule above represents a one-month review by the Technical Review Committee (TRC) staff for most minor plans that get GRU approval. All intermediate and major development plans (including Design Plats for subdivisions) are on a two month cycle. Corrected plans that require an additional staff review should be resubmitted on the submittal date for the following month. Resubmissions should include a complete new set of plans. Please verify dates with Planning Division Staff at 334-5023. Public hearings are held at City Hall, 1st Floor Auditorium, and 200 East University Avenue, Gainesville, FL.
