You get a specification sheet from the vendor, or a form approved by the City, which describes the equipment or service in detail.

You get a written price quote.

You have the specification and the price quote approved by the City.

The City issues a check for the purchase, made payable to the vendor.

You pick up your check and use it to purchase the equipment or service.

You give us a copy of your receipt within 30 days of purchase.
